- 01. It is clear that "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" are enjoying Super-High Salaries and Fringe Benefits which are at the High Levels that Our Hong Kong SAR as a whole CANNOT AFFORD.
- 02. However, it also means that "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" are REALLY Monetarily RICHER AND WEALTHIER than all the other people working in the private sector.
- 03. Our Beloved Singaporeans have used the Economically Very Sensible and Reasonable "Method of Overall Reduction of the Salaries and Fringe Benefits" of "All Their Respectable Government Servants and All kinds of Public Servants in Their Government Subsidized Organizations" by 10% or more to solve their problems successfully.
- 04. "Our Small Government of Our Hong Kong SAR" Singaporeans have also tried to act in some similar ways. But, we CANNOT DO JUST AS OUR BELOVED Singaporeans HAVE DONE WITH GREAT SUCCESS. Perhaps, it is because we have some special reasons with the Origin within Our Most Respectable and Well-Intended Basic Law.
- 05. As a result, all the people of Our Hong Kong SAR especially the younger middle class have to suffer the Greatest Pains continuously owing to the Incompetence of "Our Small Government of Our Hong Kong SAR" to CONTROL Our Public Expenditures through Reduction of the Overall Salaries and Fringe Benefits of "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" to Our Affordable Levels just as Our Beloved Singaporeans CAN and HAVE DONE SUCCESSFULLY.

- 06. Of course, all these Recurrent Irreducible Super-High Salaries and Fringe Benefits of "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" ARE THE REAL ORIGIN(S) of the Overt Worries of "Our Small Government of Our Hong Kong SAR" of the Probable Continuous Sources of Deficits and the Unbalancedness of Our Future Budgets in the Long Run. This may also be the Overt Real Reasons for Government's Adventure to Introduce the Unfair and Complicated Regressive Indirect Taxes of GST to raise Extra Revenues amounted to HK\$30Billions Hong Kong Dollars(Compensations and Special Allowances of All Kinds amounted to HK\$10Billions Hong Kong Dollars) as in the suggested So-Called Simple Rates for Calculations of 5% GST at the expense of the already lowest living standards of the poor and the Less Fortunate and also detrimental to all kinds of interests of all peoples including the Rich (perhaps with the exceptions of the people and the Accounting Professionals serving in the fields of Accountancy).
- 07. Perhaps, with the exceptions of Our Sensible SWD which have used Our Sensible Policy to CONTROL the "Public Expenditures of Our CSSA for the poorer people of Our Hong Kong SAR" within Our Overall Affordable Levels for "the Foreseeable More Poor People who may need to apply for the CSSA" through Some Overall Reductions of the Amounts of all the Recipients of Our CSSA by 11% which is in line with the Lowered Living Standards in terms of Our Consumer Price Indexes, it is very CLEAR that "Our Small Government of Our Hong Kong SAR" as a whole and as individual departments and Bureaus is Generally Unable to Control Our Aggregate Public Expenditures to Our Real Affordable Levels.
- 08. In order to Balance The Future Government Budgets, therefore, Our Beloved Financial Secretary should have to make Some Detailed Scheduled Plans to Introduce the Unfair and Most Complicated and Labour-Intensive Regressive Indirect Taxes of GST and VAT although it is VERY VERY CLEAR that Overwhelming Majority of the people of Our Hong Kong SAR have SAID

- 09. However, it is clear that Our Beloved Singaporeans CANNOT HAVE EXTRA MONEY to form Charity to do Better than the Less Efficient and Monetarily More Costly Community Services supplying by their Government Servants and the like.
- 10. Nevertheless, it is also very clear that "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" are REALLY Monetarily Richer and Wealthier. Therefore, "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" have All the Potentials to perform Great Jobs for "Our Small Government of Our Hong Kong SAR".
- 11. That is to say, "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" have the Potential Capacities to Carry Out All Kinds of Our Planned Government Community Services for the Poor and the Less Fortunate. In real terms, "the Beneficiaries of All These Community Services" include "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations and their Families" expressed in terms of their Recurrent Irreducible Super-High Salaries and Fringe Benefits with the Protection of Our Most Respectable Basic Law.
- 12. Therefore, all in all, Let "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" JOIN TOGETHER TO DO WHAT WE Hong Kong Peoples CAN DO Better than Our Beloved Singaporeans Do in terms of Humanity Through FORMING REAL CHARITY FUNDS OF ALL KINDS with ANNUAL Revenues amounted to HK\$30Billions Hong Kong Dollars to Employ Our Own Employees fully funded by Our Real Charity Funds to supply the Essential and Necessitated Community Services to all the Poor and Less Fortunate Who are in need of Our Help among the people ourselves in Our Hong Kong SAR.
- 13. Of course, we must admit that the Government of Our Beloved Singaporeans

have Less Constraints than Our Small Government of Our Hong Kong SAR. ## Return To THEME

- 01. Thank you very very much for your services as "Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations."
- 02. Of course, all of you are very hard working and full of initiatives.
- 03. You have also done good jobs that match with your jobs as Government Servants supplying all kinds of services for the public in need.

- 04. Yet, I do believe that is is necessary for all of you to know that **you** are also Financially well-supported by all the people through **paying taxes to** "Our Government of Our Hong Kong SAR".
- 05. It is also necessary for all of you to know that many many less fortunate Hong Kong people are still suffering the great pains of the Economic Crash.
- 06. As we all know, the Market Salaries in general for many positions have been drastically decreased by 30% to 50%. Nevertheless, "All of Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" are protected by Our Well-intended Basic Law.
- 07. Hence, "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" can still enjoy the Comparatively Higher Salaries and Fringe Benefits than the really LOWERED salaries and fringe benefits of all the other people working in the private sector of the Average Real Market Prices (the outsourcing services are not included).
- 08. In addition, "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" must remember that all of you are also enjoying the Highest Job Security and/or the Most Privileged Life-Long Government Servants and/or Government Pensioners Statuses which means Extra Burdens of Our Government Expenditures of the Top Priority in terms of Our Government Budgets of Our Hong Kong SAR especially at the time after the Economic Crash.
- 09. In a word, we must admit that it is very clear that "Our Small Government of Our Hong Kong SAR" CANNOT REALLY CONTROL Our Aggregate Public Expenditures as a whole with the Origin within Our Well-intended Basic Law.
- 10. Of course, it is of the Greatest Importance to RESPECT Our Well-Intended Basic Law.
- 11. Besides, it is also a fact that we CANNOT adjust Our Aggregate Expenditures to Our Affordable Levels through "An Overall and Fair Reduction of the Salaries and Fringe Benefits" of "All Our Most Beloved Government Servants and All Kinds of Employees of Public Servants of All Our Government Subsidized Organizations" by 10% or more just as some other friendly states CAN and HAVE ACHIEVED their targets with Great Successes. As a result, it is quite certain that "Our Small Government" have been abided to pay the Super-High

Salaries and Fringe Benefits to "all Our Most Beloved Government Servants and All Kinds of Employees of Public Servants of All Our Government Subsidized Organizations." Thence, "Our Small Government" CAN Never Solve the Problems of the Structural Deficit upon the True and Genuine Incompetence of "Our Small Government of Our Hong Kong SAR" to Reduce Our Recurrent Public Expenditures on nearly All Items.

- 12. Nevertheless, as we CAN Reduce the CSSA for all recipients among the poorest people in Our Hong Kong SAR by about 11% in line with the True Picture(s) of Our Living Standards and the Aggregate and Real Capacity of Our GDP, Our Sensible SWD Do Not NEED ANY EXTRA RESOURCES on one hand BUT on the other hand Our SWD Still CAN HELP MORE and MORE POORER PEOPLE of Our Hong Kong SAR who have continuously been attacked by (a) financial difficulties and many have suffered unemployment for a long time owing to the Economic Transformations owing to the Spiritually IMMORAL But Economically Sensible Decisions of their Monetary-Profit-Maximaization-Employers and (b) some stringent Government Policies which ONLY Help the Rich to be Richer but making the poor becoming really poorer and more helpless in the Figures of The Theoretically Improving and Recovering economy showing how Our Small Government (with Legal Monopoly to Collect Taxes) have been benefited among the Firsts in terms of the APPARENTLY Recovering but unstable Figures of Surpluses. (Of course, it is very clear that these kinds of surpluses are quite uncertain if we can trace the sources of these kinds of tax revenues really with sufficient Prudence.)
- 13. Therefore, (a) to be Really Sensible for the Future Our Community of Our Hong Kong SAR as a whole with the well-established Build-in and Continuously Newly Added Criteria to PROTECT THE INTERESTS OF THE RICH PEOPLE (but usually at the expenses of all the other peoples especially including the younger middle class still suffering the most innocent pains of the Economic Crash in Our Hong Kong SAR) and (b) to be Really Considerate and Thoughtful for the sakes of all the poorer and the less fortunate, "Our Small Government of Our Hong Kong **SAR**" must TRY OUR BEST to find some REAL Possible Ways to get through the Paramount Important and Insurmountable Articles 99,100,101,102 and 103 of Our Basic Law, Certainly, IT IS MORALLY WRONG to INTRODUCE the "NEW UNFAIR Most Complicated TAX SYSTEM of Goods and Services TAX" in the unrealistic name of Broadening the Tax Base. It is because IT IS Very Clear that "Our Small Government" Have Overtly Foresee That Small Government" Do Not Have Sufficient Financial Capabilities to MEET all the Planned and Irreducible (may be unnecessary and non-essential) Aggregate Public Expenditures closely Linked with the Establishment in Our Projected Future.

- 14. Dearest "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations", Today the 9th of August, 2006AD (Wednesday) Anno Domini is the Happy Birthday of Our Beloved Singapore as Part of Our Humanity on Our Earth. In addition to expressing Human and Humane and Sincerest Congratulations to all Our Concerned Beloved Fellow Human Creatures, it is also of importance for "All of us and All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" to think REALLY CAREFULLY AND THOUGHTFULLY why Our Singaporeans can be more successful on the Government Budget Management. (Certainly, the Successes of Our Beloved Singaporeans are BUILDING FIRMLY UPON THE REAL COMPETENCE of the Government of Our Beloved Singaporeans to CONTROL THEIR Government Public Expenditures within their Affordable Levels of their Economy BUT ARE NOT Building Upon their Unfair and very complicated but perhaps agreed taxes of the GST.
- 15. It is very clear that Our Singapore Government REALLY CAN and HAVE Already RE-ADJUSTED their Affordability on the Right Track through Sensible and Reasonable and Rational Reduction of the Overall Salaries and Fringe Benefits of All Their Respectable Government Servants and All kinds of Public Servants in Their Government Subsidized Organizations.
- 16. However, it is also a fact that "Our Small Government of Our Hong Kong SAR" CANNOT Act in Some Similar ways. Certainly, "Our Small Government" did attempt to try their Greatest Local Efforts.
- 17. Undoubtedly, there are still lots of ways that We the people of Hong Kong CAN DO BETTER THAN OUR BELOVED SINGAPOREANS.
- 18. First of all, after the overall reduction of the salaries and fringe benefits of All Their Respectable Government Servants and All kinds of Public Servants in Their Government Subsidized Organizations, it is clear that the Singapore Government Budgets are stabilized. However, All Their Respectable Government Servants and All kinds of Public Servants in Their Government Subsidized Organizations CANNOT become Comparatively RICHER and WEALTHIER than the people working in the private sector owing to the facts that all of them have to act with on accord through the Consensus of their Democratic Government in the Style of Most Respectable Parental Guidance with Humanity. That is to say, All Their Respectable Government Servants and All kinds of Public Servants in Their Government Subsidized Organizations CANNOT HAVE REAL EXTRA MONEY TO FORM

CHARITY ORGANIZTIONS to HELP THEIR GOVERNMENT TO IMPROVE THEIR COMMUNITY as a whole.

- 19. Of course, Our Hong Kong SAR is very different. That is to say, "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" can still enjoy the Comparatively Higher Salaries and Fringe Benefits than the real salaries and fringe benefits of all the other people working in the private sector of the Average Real Market Prices (the outsourcing services are not included).
- 20. As a result, "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" are REALLY RICHER AND WEATHIER than all the other people of Our Hong Kong SAR working in the private sector of the Average Real Market Prices (the outsourcing services are not included).
- 21. If "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" ARE ONLY USING these moneys in their own interests through Private Consumptions and/or Personal Investments, then "the Gap between the Rich and the poor" is not only widening continuously at present but "the Gap" will probably become an Abyss in Our Near Future.
- 22. In addition, owing to (a) the Over Private Consumption by only some smaller Groups of people and (b) the Unrealistic and Fault Pictures of Monetary Gains of the Over Private Personal Investments of also the same smaller Groups of people, the General Consumer Price Indexes are being expected to be increasing. As a result, the poor people and all the retired people will certainly Suffer the Greatest Pains of These Kinds of UNFAIR INFLATION with the Origin in Our Incompetence to CONTROL Our Public Expenditures of "Our Small Government" within Our Real Affordability.
- 23. Nevertheless, If "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" CAN USE THESE MONEYS which is amounted to \$30Billions Hong Kong Dollars or more in every Financial Year to Build Up Some More Efficient and Less Costly Real Charity Organizations to CARRY OUT "Our Government's Essential and Reasonable Community Services to the people of Our Hong Kong SAR", then it is certain that We CAN Be Better Than Our Beloved Singapore Government's Salaries Reduction Policy.

- 24. It is because these Suggested Actions to be done by "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" ARE FULL OF HUMANITY and ARE TRULY AND GENUINELY PROOFS of OUR SUCCESS(ES) IN OUR TRUE and GENUINE HUMAN and HUMANE EDUCATION.
- 25. Our Dearest "Most Beloved and Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations", Let all of us Join Together to HELP our HELPLESS "Small Government of Our Hong Kong SAR" to get through the Insurmountable and Foreseeable Deficits owing to (a) the Super-High Salaries and Fringe Benefits of "All Our Respectable Government Servants and All kinds of Public Servants in Our Government Subsidized Organizations" and (b) their Recurrent Basically Self-Interest-Oriented and Reasonable Micro-Economic ways of thinking and of personal/family consumptions and of person/family investments.
- 26. Indeed, all these actions may lead to the Greatest Abyss between the Rich People and the poor people through continuous Inflation owing to (a) Over Personal Private Consumption of Some Richer People and through Unrealistic and Fault Gains in Speculative investments owing to (b) Over Personal Private Investments of Some Richer People. In turn, the So-called Low TAX Rates of some kinds of Regressive Taxes will not be enough to raise sufficient Extra Revenue for "Our Small Government" to Meet the Super-High Salaries and Fringe Benefits of "All Our Respectable Government Servants including the Great Number of Newly Recruited TAX COLLECTORS responsible for the collection of the UNFAIR and Most Complicated Regressive Indirect Taxes and All kinds of Public Servants in Our Government Subsidized Organizations".
- 27.
