I'm just a simple citizen of HK, and would like to suggestion some option as below for your reference:-

1) Selling & Buying taxes

I do agree our taxes backup is not strong enough, and I do agree to have the selling and buying taxes. BUT I think this new taxes range?MUST not include the following items:-

- a) Basic food:-
 i) rice & flour
 ii) sugar & salt
 iii) oil

b) Basic medical medicines
