Ongoing Consultation on GST

We write with reference to the upcoming debate in Legco on GST consultation.

Since GST would have far-reaching economic and social implications, a thorough, community-wide, in-depth consultation is indispensable for constituting consensus among all walks of life. Past experience has shown that even fundamentally sound policy proposals can run into stern opposition if the public feels that they have not been adequately consulted and their concerns have not been fully addressed. For these reasons, it is more than advisable for the Government to set aside a consultation period as long as nine months, so that transparent, rational and dispassionate discussions can be facilitated and all members of our community can make their voice heard.

CMA's official position on GST is that we welcome thorough consultation.

We would be much obliged if you could help convey our views to the esteemed members of the Legislative Council, who are a vital element of the GST consultation. Thank you.
