Base Will Always Be Sufficiently Broad To Support “Our Genuinely Prudent

Non-Extravagant Thrifty Public Expenditures” . Therefore, No More Immoral  
“GST” or “VAT” is needed to be publicized or ... Amen Amen Amen.

01 If “Our Small Government and All Kinds of Employers” Can Try Every  
Effort To secure “The jobs of All Our Most Hardworking Hong Kong People” ,  
Then “Our Tax Base” Will Always Be As Broad As “Our Fully Employed  
Workforce of Our Small Hong Kong SAR” . And Thence, No “Regressive and  
Unfair if not Immoral GST or VAT” is Needed.

- In other words, “Our Whole Community” Can Be Confident That “With  
'Our Simple Tax System' and ' The crystallized Most Prudent Ways of Our  
Ex-Financial Secretary Sir Phillips ' ” To Say (1) “Our Continuous  
Non-Recurrent Revenues in the forms of Prepaid Land Sales Amounts in  
Auctions in the next forty years of Our Hong Kong SAR” , and (2) “Our  
Foreseeable Less Stable Government Taxes and Revenues of All Kinds” may  
still be sufficient To Support “Our Prudent Non-Extravagant and Truly  
Essential Government Expenditures.”
- Indeed, We Have Probably Lived Through This Difficult Period of “The  
Longest Historical Eight Years of Deficits” . Yet,
- (1) “Our Government Servants and Public Servants of Our Government  
Subsidized Organizations (including “The Public-Fund-Trained-and Nurtured Nurses  
of Our Hospital Authority” in The Period when 'very few Hong Kong Ageing People  
Without Medical Insurances' Can Afford “The High Costs of The Under-Utilized But  
Already Sufficiently Staffed With Trained Nurses Private Hospitals ' Services” Before  
'Our Mainland Rich Women and Hong Kong Resident Rich Mothers-To-Be' Can Afford  
To Pay “Huge Amounts In the Obstetrical Wards in the Private Hospitals” and thence  
instantaneously “the Then Under Utilized Private Hospitals” Use “Some Legal But  
Immoral and Unscrupulous Money-Oriented-Ways” To Loot Away “The  
More-Mercenary-But-Less-Nightingales-Oriented-and-Public-Funds-Trained-and-Nurtured  
-Nurses” who Did Not Know “The Ideals of Our Rosanna Tam Wong Yick Ming” )  
” (a) have still been Protected By “The Buffer of Our Prudently Saved  
Reserve in the Previous Forty years of Prosperity” and (b) have become  
“The Only Groups of Most Fortunate and Well-Protected Hong Kong SAR's  
Peoples Who Needed Not Share The Difficulties of The Asian Economy  
Crash in 1997 Anno Domini” , and
- (2) (a) We Can Still Afford To Use “Our\$100plus Billions Dollars of Our  
Government Reserve of the Prudently saved \$400Billions Dollars since Our  
Far-Sighted Most Beloved Late-Ex-Financial Secretary Sir Phillips Haden  
Cave” to Pay Continuously the “IRREDUCIBLE and Comparatively Super  
High Salaries and Fringe Benefits of All Our Government Servants and

Public Servants” and (b) we now still have about \$280 Billions Dollars Reserve though at the same time it is also understood that Our Government's Potential Liabilities remain very high.

- Nevertheless, “Our Beloved Government Servants” SHOULD

REMEMBER that the Non-Government Related Real Market Salaries HAVE PLUNGED by 30% to 50% since the Asian Economic Crash in the second half of the year 1997 Anno Domini.

02 However, if “Our Small Government and All Kinds of Employers” Abuse “The Efficiency of Our Advanced Technologies ONLY for their own Self-interested Oriented Benefits on one hand ” But on the other hand At The Legal but inhumane and immoral expense of “All The Livelihood of hundreds of thousands of Already Less Fortunate Poor and Hardworking Factory Workers who have helped 'Our Small Government and All Kinds of Employers' to become “World Renowned Billionaires' or 'Legal but Directly or Indirectly Legal But Immoral Real Capitalistic Bosses” , Then (1) “The Profit Tax and Property Tax” Can Certainly Be Increased Drastically as happened and (2) “The Salaries Tax From Most Senior Government Officials” Can Also Be Increased Drastically as happened. But, “Our Rate of Unemployment among the community” Will Also Be Double or Triple or Increased To Higher More Amount of “Our Conventional 2% Rate of Unemployment as The Then Metropolitan of Manufacture Industry” .

03 Indeed, if “Our Billionaires Capitalists” Can Be “Some Good Employers” As Good As “Our Small Government of Our Hong Kong SAR as Legal Employers” , Then in “this Happy era of automation and computerization” , “all the hardworking But Less Fortunate and monetarily poor factory workers” should be morally be awarded with “the honourable Pensioner statuses” similar to “The Fortunate Government Pensioner including some of Our Government Young and Comparatively Early Retired Government Officials To Save Government Recurrent Expenditures and Not Sufficient Government Jobs Needed To Be Done while there are still “many other excellent younger Senior Government Officials” who Can Be Transferred To Take Up “The Original and New

Reshuffled Jobs Left after the Said Senior Retired Earlier Than Ageing” with “the help of Automation and Computerization” .

- For example, “Our Beloved and considerate Raymond Ng who cares “Government deficits” and “Fewer and Fewer Real Jobs in (1) RTHK Automation and Computerization and (2) Higher and Higher Academic Qualifications of New Generations of Government Servants RTHK Colleagues” comparatively earlier retired as “a young Head of Our RTHK” . We Can Transfer “Our Most Excellent Grace Fu” To Help “All Our Excellent RTHK Colleagues” To Work On To Serve Hong Kong People. We can also save “A Little Bit of Government Expenditures and thence contributive to Narrowing The Deficits Unpredictable” owing to Economy Transformation of Our Small Hong Kong SAR ” . Moreover, “Our Beloved Young and Early Retired Raymond” Can use “his free time with his children and Tang Oi Lam and other family members to Promote Model Family” with “The Deserved Pension money” to do what “Her Majesty and All Faithful Christians” Have Taught us To Do. That is, “we the more fortunate Fellow human creatures” should help “the Less Fortunate fellow human creatures” who are in need as in the Gospel According To Saint Matthew Chapter 25, Verse 40.

04 Although Paragraph 209 says

“209. The most noticeable and easiest-to-predict impact of GST would be on inflation. The imposition of GST would push up the retail price of most expenditure items. Assuming a GST rate of 5%, our modelling suggests that the Composite Consumer Price Index (CCPI) would be expected to rise by only around 3% immediately after GST introduction. The GST-related CCPI increase would be on top of the underlying prevailing inflation rate at the time. However, it would be a one-off spike and be expected to dissipate quickly.”,

There is still rather high probability that “The Suggested 'Higher than the expected initiate rate for simplification of thinking' 5% GST” may probably Create “Vicious Cycles of Continuous Inflation a few times higher than The Suggested Full Rate of GST 5%” . “The suggested indeed Underestimated Composite

Consumer Price Index” (CCPI) would Never Be as low as “Only Around 3%” .

- It is because although “Our Small Government” Suggests That “The Registration Threshold Be Set At The Annual Turnover of \$5million Dollars For Only The Targeted 65000 Hugh and Big Businesses mentioned in Paragraph 84” ,  
(Perhaps Mainly Owing To “Limited Numbers of Government Servants Planned To Be Employed” as “New Government Officials To Collect The New and Unfair and Immoral GST” if “The Special Delicate Relations” Between “Our Hong Kong SAR Commercial Sectors” and “Our Small Government and The Government Senior Officials” Be Taken Into Account For Really Thorough Considerations, ), it is certain that
- (1) “ All the 750000 Smaller Businesses even optioned not to register” will Undoubtedly Still Need To Spend “No Less Than The Equal Amounts” For Paying “The Same Unfair and Immoral Regressive GST” indirectly via “their bigger partners and suppliers” , and
- (2) “All Consumers of the Retailers” will also certainly need to pay “all kinds of expenditures that 'the producers and wholesalers and retailers and what nots' already spend to employ 'New Account

Workers and Accountants To Calculate Their parts of GST' In addition to “The Parts of GST for consumers” as the “Most Unfortunate and Poor or Rich Targeted Final Tax-Burdens Bearers” .

05. Dear Mr Tang Our Incumbent Financial Secretary and All Our Senior Government Officials, as in the Executive Summary quoted below:

A substantial reduction in personal allowances would not address concerns over an ageing population as this would still leave our tax base overly reliant on taxation of income.

06. Therefore, we should .
